## IN THE SPOTLIGHT

Life Imprisonment and the Right to Hope - by Dirk van Zyl Smit\*

All prisoners, including those sentenced to life imprisonment, should have a prospect of release. Failure to provide for such a prospect by setting up a mechanism to review life sentences after a reasonable period amounts to inhuman and degrading treatment, which infringes the prohibition on such treatment in Article 3 of the European Convention on Human Rights. This was the essence of the decision on 9 July 2013 of the Grand Chamber of the European Court of Human Rights in the case of <u>Vinter and others</u> <u>v United Kingdom</u>.



## ALTERNATIVES AND IMPROVEMENTS TO IMPRISONMENT

(1 July) A national strike by Kenya's teachers has not prevented more than fifteen school heads and deputy heads taking part in PRI's latest training seminars designed to promote alternatives to prison in East Africa.

## JUSTICE FOR CHILDREN

## Eight country research reports on policy and legislation to prevent and address violence against children

The eight country research reports - developed over the past year and now available in a range of languages - aim to increase the understanding of the specific legal and policy measures that can work to prevent and remedy violence against children. The reports focus on police and pre-trial detention settings where children are most at risk of being subject to violence. The countries covered are Bangladesh, Georgia, Jordan, Kazakhstan, Pakistan, Russia, Tanzania and Uganda.

## WOMEN IN THE CRIMINAL JUSTICES SYSTEM

(6 July) PRI and partner organisation, <u>Bangladesh Legal Aid and Services Trust (BLAST)</u> organised a one day training session for prison staff on implementing the <u>Bangkok Rules</u> for women prisoners. PRI's Executive Director, Alison Hannah, writes about issues faced in women prisons in Bangladesh, including those relating to healthcare and hygiene (such as access to sanitary pads), uncomfortable visits with families, and the need for rehabilitation and reintegration support.



# Launch of Bangkok Rules on women offenders and prisoners: Toolbox for Implementation

On 16 October, in the margins of the 3rd Committee at the United Nations in New York, PRI will launch three new tools aimed at assisting with the implementation of the UN Bangkok Rules. This toolbox will include a <u>Guidance Document and Index of</u> <u>Implementation</u> will be published, with the Thailand Institute of Justice, and an e-learning course, <u>How to</u> <u>address the needs of women in detention: based on</u> <u>the Bangkok Rules</u>, developed with Human Rights Education Associates, will go live. All three tools will be available in Arabic, English and Russian.

## **TORTURE PREVENTION**

#### New assessment tools for NPMs

PRI and the Association for the Prevention of Torture are developing a practical assessment tool for NPMs and other monitoring bodies to support them in conducting effective visits to places of detention, and to explore particular thematic issues relevant to monitoring. The tool will include both practical components and checklists, and a series of papers on topics relevant to torture prevention, including pre-trial detention, gender-sensitive monitoring, institutional culture in prisons, security and dignity, and issues facing LGBTI detainees.

The tool was piloted with the Georgian NPM in Tbilisi at the end of May, and it will be launched in October 2013.

# UN Special Rapporteur on Torture announces new website - and upcoming thematic report

The SR on Torture, Juan E Méndez, and the Washington College of Law have launched a new website for the Anti-Torture Initiative (ATI), available at <u>www.antitorture.org</u>.

An upcoming thematic report to the 68th Session of the General Assembly in October 2013 will focus on the UN Standard Minimum Rules for the Treatment of Prisoners (SMRs) as they relate to various issues of torture and cruel, inhuman and degrading treatment or punishment.

## **ABOLITION OF THE DEATH PENALTY**

#### Abolition in Tajikistan: New recommendations and commitments

(21 June) PRI (Central Asia Office) held a roundtable with government officials, judges, NGOs and international experts/representatives on the death penalty and life imprisonment in Tajikistan, with the financial support of the European Union and Ministry of Foreign Affairs of Switzerland. Tajikistan officially declared a moratorium on the death penalty in 2004. They key recommendations that came out of the roundtable included the need for a public awareness-raising campaign; amendments to national legislation; learning from international experience on abolition; and to improve the work of state agencies on the importance of abolition. State officials and MPs committed to developing and implementing the recommendations.

#### Death penalty in Belarus

(17-21 June) Various meetings and events were attended by PRI (Russia, Belarus and Ukraine Office) on the death penalty in Belarus during June. These included a <u>series of</u> <u>task-force meetings</u> with members of the Belarusian Working Group on the death penalty and a roundtable with the Council of Europe where PRI presented results of research conducted on the topic.

#### World Congress against the Death Penalty

The right to hope? Views on the life imprisonment ECtHR judgment and other news from PRI

(12-15 June) PRI participated in the 5<sup>th</sup> World Congress against the Death Penalty in Madrid which brought together over 1,000 actors fighting against the death penalty. During the three day meeting NGOs, politicians, lawyers and academics reviewed death penalty developments and discussed abolitionist strategies at the national, regional and international levels with a specific focus on the regions of Africa and the Middle East. These strategies will encourage complementary action by States, intergovernmental organisations and NGOs.
